
Herein you will find the results of the deliberations of the College of Heraldry of Atlantia in August, 2004:

Edan MacKay. New name.


Gustav von Silberwald. Resubmission of device. Per bend vert and azure, two horse's heads coupé and addorsed argent.



Gwennlian Pengrych ferch Rhys. Appeal of Golden Dolphin return of device. Or, three harpies displayed gules, winged and tailed sable.



Isabella Barozzi. New name and device. Gules, a saltire moline disjoint argent within a bordure Or.




James Oleveir. Resubmission of device. Quarterly vert and gules, a raven contourny and in base three bars argent.



Jonas the Bald. New name (see RETURNS for device).

Joscelin d'Outremer. New name.


Maria Caterina di Boni. New device. Purpure, a sea-cat erect and in canton a decrescent, on a base wavy argent, three barrulets wavy azure.



María González de la Magdalena. New name.

Storvik, Barony of. New badge. Azure, a label couped ermine.


Susane d'Anjou. New name.




RETURNS:

The following submissions have been returned for further work:


Elric Kinslayer. New name and device. Per pale argent and sable, a cross throughout, splayed at its ends, counterchanged. Though mention of Michael Moorcock was intentionally omitted from the Internal Letter of Intent, the vast majority of commenters noted presumption and/or conflict with the albino hero of Moorcock's Melniboné stories. Given the diversity of background in those calling this as a problem, I have little hesitation in returning this for infringing on Moorcock's hero. Since there is no registerable Society name, this would have to be returned in any case. However, though the cross was blazoned on the forms as a cross formy, nobody was able to document this particular form. Thus we are returning this with a recommendation to the submitter to use a more standard form of cross.



Jonas the Bald. New device. Sable, on a chief argent three crosses potent sable. Unfortunately, this conflicts with Conflicts with Moira of Northern Outpost (“Sable, on a chief argent a rose purpure between two roses sable.”) and Rhonwen of Rhyl (“Sable, on a chief argent a swan naiant wings addorsed issuant from the line of division gules.”) Two differences are required between pieces of protected armory for registration and there is only one difference for the changes to the charges on the chief.



María Gonzales de la Magdalena. New device. Argent, a rose proper on a chief sable, three crosses formy argent. Unfortunately, this has to be considered in conflict with Sean Rose McGregor (“Argent, a rose azure, slipped and leaved vert, on a chief sable, three crosses formy fitchy argent.”) Two differences are required between pieces of protected armory for registration and there is only one difference for the change in tincture of the rose since precedent from February, 2002, indicates that the presence of a slip and leave does not create difference. (The fitching of the crosses on the chief in Sean’s armory is a minor detail that does not give difference in this context.)



Otto von Schwyz. Resubmission of badge. (Fieldless) A sealion erect guardant argent. This conflicts with Boneth of Glenarvon (“Per saltire counter-ermine and azure, a sea-lion rampant regardant argent.”) Two differences are required between pieces of protected armory for registration and there is only one difference for the modifications to the field.



Storvik, Barony of. Order of the Silkie’s Pup. New order name. As the Barony already has an order name with the spelling *silkie*, there is a good case for this spelling being “grandfathered” to the Barony despite the modern dating in their documentation. However, documentation in commentary demonstrated that the use of pup for a seal is not period and may be even dicey for small dogs, though *puppy* may be period. Also, no documentation was provided for the use of young forms of animals in order names in period and similar “kitten/puppy” forms have previously been ruled ineligible for general use in Society armory so they cannot be documented as a period heraldic charge.
