
The Laurel Office has notified us of the results of its considerations at meetings in August, 2004. These results were conveyed in a letter received in Atlantia on 25 January, 2005.

Ælfwynn of Boscastle. Name.


Áine inghean uí Fhathaigh. Name.

Alana Urquhart. Name and device. Sable, a rose between three decrescents argent within a bordure argent goutty de sang. In accepting the device the Laurel staff asked that the rose be drawn larger than on the submitted emblazon to emphasize its status as a primary charge.




Alessandra Ruscello. Badge. Per fess wavy azure and Or, an increscent Or and a crab gules

Atlantia, Kingdom of. Order of the Sea Dragon. Order name




Aurelia Aurifaber. Household name and badge for House Oakenham. Sable, a hammer fesswise and on a bordure argent in cross four oak leaves in orle vert. The Laurel staff felt that the submitted household name of House Oakenhammer was insufficiently documented and so modified it to the locative form Oakenham which they felt was better documented as a period form.




Auric von Regensburg. Name and device. Per pale gules and sable, a chevron embattled Or. The Laurel staff asked that the chevron be drawn wider and with fewer embattlements.




Brian Killian the Red. Badge. (Fieldless) A grenade within and conjoined to four crescents conjoined in cross at the points Or.




Cecille de Lorraine. Name and device. Argent, on a chevron between three eagle's heads erased breathing flame azure two swords points to center argent. The Laurel staff modified the submitted given name form Cécile to the form Cecille shown in a French source from 1587 as they felt it was a more appropriate period form.

Danyel Volker. Name and device. Per pale gules and Or, an axe sable and a chief ermine.



Declan Mac Dockery. Name and device. Azure, on a cross quarter-pierced Or four acorns bendwise gules, overall two swords in saltire argent.

Duncan Straloth. Name.

Eadan maol. Name. The Laurel staff modified the originally submitted name Eadan maol Cécht (Eadan servant of Cécht) to Eadan maol (Eadan the Bald) because they felt that the use of the name Eadan was presumptuous because the daughter of the divine Dian Cécht was named Etan and because they felt there was insufficient evidence for a pattern of period Irish names formed with a given name + maol + another given name.

Eilionora inghean Uilliam. Name and device. Or, a phoenix, head to sinister, issuant from base gules and in chief three suns sable.

Elizabeth Montague of York. Name.

Guenièvre de Monmarché. Change of name from Generys ferch Ednuyed ap Madauc. Her former name of Generys ferch Ednuyed ap Madauc was retained as an alternate persona name.


Isolde Corby. Acceptance of transfer of badge from Rhiannon ui Neill. Azure, a decrescent and a gore sinister argent.

Iustinos Ancyrenos. Device. Gules, four mascles conjoined in pale argent.


Jaine Elizabeth Parr. Change of name from Jaine the Embroiderer.


Jane Alexandria FitzPatrick. Name.

Karen Larsdatter. Badge. (Fieldless) A strawberry per pale gules and argent capped and slipped vert.










Katherine d'Anjou. Change of device. Vert, a fess embattled between three Latin crosses fleury, all within a bordure argent. Her former device ("Purpure, on a chevron inverted Or three roses purpure.") has been released.




Marryn Blackgroves. Name (see RETURNS for device).

Muriel of Aberdeen. Name and device. Per chevron inverted embattled sable and argent, in pale a sheaf of three needles argent and a fox's mask proper.






Otto Jager. Name and device. Sable, a fess embattled between three Maltese crosses argent.




Orn gráskeggr. Name and device. Azure semy of hawks striking to sinister, a bordure Or.

Rhiannon ui Neill. Transfer of badge to Isolde Corby. Azure, a decrescent and a gore sinister argent.


Roana de Laci. Household name for Worshipful Company of Saint Matthias.




Rodrigo Peregrino de Navarra. Name and device. Argent, on a bend vert between two falcons striking gules, a sword Or.




Rónán mac an Stalcair. Badge. Gules, in pale a skull and a crescent argent. The Laurel staff requested that both charges be drawn larger and at the same size as each other.



Rowen the Shiftless. Change of device. Gules semy-de-lys Or, a lion couchant argent. Her previous armory ("Per bend sinister Or and gules semy-de-lys Or, in dexter chief a natural leopard's head erased sable.") is released.



Simona dell'Amore. Change of name from Ciar inghean uí hEidirsceóil and change of device. Sable, an elephant rampant argent. Her former armory ("Per pale argent and sable, a besom and a scythe crossed in saltire counterchanged.") is retained as a badge.




Susanna von Schweißguth. Device. Gules, a fret and on a chief Or three leaves bendwise sinister vert.

Teresa de Caragoça. Name.

Thorgrimmr inn kyrri. Badge. (Fieldless) A lymphad with oars shipped argent, sails set and pennoned sable.

Vladimir Davidovich. Name.




The following items were RETURNED by the Laurel Office:

Angus Ó Coileáin. Device. Per saltire Or and gules, in pale two thistles slipped and in fess two lions combattant, all counterchanged. The Laurel staff returned the device for redrawing because they felt that the charges in pale were not adequately identifiable as thistles.


Atlantia, Kingdom of. Heraldic title Kanatatsu Herald. This title was returned because the Laurel staff ruled that, while Japanese personal names are registerable, "a Japanese heraldic title falls outside the defined scope of the Society".

Marryn Blackgroves. Device. Per pale purpure and sable, a unicorn's head couped argent armed Or within a bordure wavy argent semy of oak leaves sable. The Laurel staff returned the device because they felt that the leaves were not in a standard heraldic position, suggesting that the leaves either be all palewise or follow the line of the bordure.






Nimenefeld, Canton of. Device. Gules, a garb within a laurel wreath and on a chief Or, a demi-sun gules. The Laurel staff returned the device because the Laurel wreath did not meet their current standards, requiring that the laurel wreath on the submission be redrawn "so that it is round and has only a small gap, or no gap at all, between the tips of the branches"



Olaf Wulfbrandt. Household name and badge for Haus Gebrochen Brüke. (Fieldless) A castle fracted palewise gules. The Laurel staff returned the household name because they felt that there was insufficient evidence that it followed a period pattern in German for naming groups of people. The charge on the bridge originally blazoned as a bridge was reblazoned as a castle and the badge was returned for conflict with Edwin FitzLloyd ("Ermine, chaussé raguly vert, a tower gules.")
