
The Laurel Office has notified us of the results of its considerations at meetings in July, 2004. These results were conveyed in a letter received in Atlantia on 29 December, 2004.

The following items were REGISTERED by the Laurel Office:






Anna van Brabandt. Device. Per saltire argent and Or, a tulip flower sable.



Arnbiørn Bassi Dansson. Device. Barry of four vert and argent, on a cross formy quadrate Or a bear's head cabossed gules.




Christopher MacConing. Name and device. Per pale azure and argent, a tower Or and on a chief sable three garbs Or. Since the submitter requested authenticity for Scotland in the fourteenth through sixteenth century, the Laurel Office modified the byname from mac Coning in registering the name.




Con O'Quyrke. Name and device. Vert, a sea-dog argent within a bordure engrailed Or.



Elizabeth Harlyn. Device. Azure, in pale three roses between flaunches Or.




Eóin Ó hEochaidh. Badge. Azure, on a rose argent a sword inverted sable all within a bordure Or.







Griffith Jenner. Name and badge. Argent, masoned, on a demicartouche issuant from base sable, an A-frame plumb line Or.




Hannah bat Levi. Device. Or, a pomegranate slipped and leaved and on a chief embattled gules, three roses Or.

Hróðný Rognvaldsdóttir. Change of name from Róisin of Rowanwood.






Ysane de la Selle. Name and device. Paly bendy azure and argent, a fleur-de-lys within a bordure Or.




The following items were RETURNED by the Laurel Office:

Abel Bremer. New name and device. Azure, in pale three bells, two and one, and two spears crossed in saltire Or. This was withdrawn by the submitter after he determined that virtually identical submissions thought "lost" before he moved to Atlantia had in fact been processed by the College of Heralds of the East.



Griffith Jenner. Device. Per fess embattled sable and argent masoned sable, in chief an A-frame plumb line between two pairs of compasses Or. Unfortunately, the Laurel staff deemed that the charges in chief fell afoul of a precedent that bans use of more than one type of very similar charge in the same charge group (e.g., using a sword and a dagger in the same group of charges). While the compasses and the A-frame plumb line are both period instruments, only the compasses are used in heraldry and they felt that the two charges were visually confusing. We believe that the armory would be registerable if all the charges in chief were plumb lines or all were compasses.



Sorcha inghean Mhaoláin. Name. Unfortunately, this name was returned for conflict with the name of Sorcha inghean uí Mhaoláin.
