
Unto the populace of Atlantia, greetings from Alisoun MacCoul of Elphane, Golden Dolphin Herald!

The Laurel Office has notified us of the results of its considerations at meetings in January, 2005. These results were conveyed in a letter received in Atlantia on 26 April, 2005.

The following items were REGISTERED by the Laurel Office:


**Alessandra Bencini.** Name and device. Ermine, a unicorn passant and on a chief purpure, three suns argent.



**Andreas de Caunteton.** Badge. (Fieldless) A lion rampant chevronelly Or and azure.




**Androu Weaver.** Name and device. Barry and per pale argent and gules, in pale three bears passant sable.




**Anne du Cygne Noir.** Device. Argent, a swan naiant sable and on a chief wavy purpure three fleurs-de-lys Or.



**Beatrice Villani.** Device. Argent, three irises purpure slipped and leaved vert, a chief invected purpure.




**Bjorn Arnaldsson.** Name and device. Sable, three Bowen knots argent within a serpent involved head to base, Or.



**Blitha of Wolfhou.** Device. Azure semy of wolf's paw prints argent, on a pile inverted ployé throughout Or a tower azure.






**Constantina Tagarina.** Device. Azure, on a lozenge argent a sprig of alder, a bordure argent.


**Cuilén Ó Cinnéide.** Device. Per bend sinister indented argent and gules masoned argent.



**Eadan maol.** Device. Per pale azure and purpure, a rapier and overall in saltire two arrows inverted Or.




**Edonea MacKay.** Name and device. Azure, a sun in splendor and on a chief Or three ravens sable.




Elspet Byndelase. Device. Gules, a chevron vair-in-pale.

**Emma Rudolfstochter.** Name. The name was submitted as Emma Rodulfstochter. Since the submitter requested authenticity for fifteenth-century German, the Laurel staff modified the form of the given name in the patronymic since they felt the usual form of the name in the fifteenth century would be *Rudolf* while *Rodulf* was more common in the thirteenth century.




**Erich von Oßenbrugge.** Name and device. Gules, in fess an oak tree couped and a griffin sergeant Or. Since the submitter requested authenticity for fourteenth-century German, the Laurel staff modified the place name from Osnabrück, which is later, to a form that appeared in 1488.


**Guenièvre de Monmarché and Girard le Bourguignon.** New badge. (Fieldless) A fleur-de-lys per pale argent and azure.




**Günter Weiss.** Name and device. Gules, on a roundel engrailed argent a tree blasted and eradicated sable and on a chief argent two boars statant addorsed gules.




Jeneuer Brock. Name and device. Purpure, a brock's head erased Or.




**Josep le Capeller.** Name and device. Per fess ermine and sable, a stallion salient gules within a bordure engrailed counterchanged. The name was submitted as Josep Estienne le Capeller. Since the submitter requested authenticity for the fourteenth century, the Laurel staff dropped the Estienne because they considered such combinations of two given names or a patronymic name combined with an occupational name to be very rare until the sixteenth century.




Josep le Capeller. New badge. Per fess invected ermine and sable.



**Kaleeb al-Akhdar.** Name and device. Argent, a die gules marked argent. The name was submitted as Kaleeb al-Hadra', but the Laurel staff changed the byname to the equivalent masculine form since the given name was documented only as a masculine form and in Arabic such descriptive bynames have to agree in gender with the gender of the given name.




**Lazaros Tagaris.** Device. Sable, on a bend sinister engrailed between two crosses of four lozenges Or a scarpe gules.




**Lodwig von Neusohl.** Name and device. Gules, on a fess dovetailed Or, a broad axe reversed and inverted sable.

Malcolm MacCullum of Moffat. Name and device. Per chevron embattled sable and Or, two lions combatant and a tower counterchanged. The Laurel staff modified the preposition in the name from "de" to "of" because they felt that using "de" implied that "de Moffat" was an inherited surname and they felt that two inherited surnames were not documented for period Scotland, but that combining a byname with an entirely Scots locative byname was.




**Mariss Ghijs.** Name and device. Argent, a fess wavy azure between three seeblätter gules.






**Rebecca von Zweckel.** Name and device. Or, a horse passant contourny sable within a bordure embattled vert. The submitter was able to claim "grandfather" privilege by virtue of her husband whose name (Kollack von Zweckel) was registered in January, 1995.




**Richard Foxmoore.** Name and device. Argent, a unicorn's head couped contourny azure and on a chief sable a sword reversed argent.




**Rudolf der Schütze.** Name and device. Argent, a tower gules within a bordure quarterly sable and vert. The name was submitted as Rodulf der Schützer. Since the submitter requested authenticity for fifteenth-century German, the Laurel staff modified the form of the given name since they felt the usual form of the name in the fifteenth century would be *Rudolf* while *Rodulf* was more common in the thirteenth century. They also felt that the grammatical form of the byname for that period would not have the final "r" so dropped that to register the name.




**Sadb Dánae.** Name and device. Azure, a tree blasted and eradicated argent within an orle Or.




**Safiyah al-'Attarah bint 'Abd al-Rahman.** Name and device. Argent, a hedgehog rampant sable its quills impaling grapes pirpure maintaining a mortar and pestle Or, a bordure rayonny azure. The name was submitted as Safiyah al-'Attariyah bint 'Abd al-Rahman. The Laurel staff modified the form of the nisba or byname because the Arabic experts in the College of Arms indicated that the correct grammatical form would be *al-'Attarah* rather than the submitted *al-'Attariyah*.




**Saige of Lochmere.** (See RETURNS for name). Holding name and device. Per pale vert and sable, a tree blasted and eradicated within a bordure Or. As the name was returned the armory was registered under a holding name formed by the submitted given name and the name of her home group.




**Sciath ingen meic Con.** Name and device. Per fess gules and argent, a rose argent and a swan naiant sable.




**Siobhán le Wilfulle.** Name and device. Purpure, in pale a decrescent Or and a dove close contourny maintaining in its beak a moonflower argent slipped and leaved Or.



**Skorri Einarsson.** Name and device. Gyronny azure and argent, a domestic cat statant Or within a bordure gules.




**Stephan of Churchton.** Device. Azure, a chevron ensigned with a Latin cross between three annulets engrailed on the outer edge Or.




**Táriq ibn Khalil.** Device. Per pale argent and sable, two horses salient respectant counterchanged and on a chief rayonny azure three crescents pendant Or.


Timothy Macalpin. Name.



**Vilhjálmr assa Vilhjálmsson.** Name and device. Or, a chevron rompu sable between two eagle's heads erased addorsed gules and a phoenix sable.




**William of Caer Mear.** Holding name and device. (See RETURNS for name). Argent, a wolf rampant and on a chief purpure, three crosses flory argent. As the name was returned, this was registered under a holding name composed of the submitted given name and the name of a registered Society group.



The following items were RETURNED by the Laurel Office:

Andreas de Caunteton. Device. Per pale Or and azure, two lions combatant counterchanged. Unfortunately, the Laurel staff returned the device for conflict with the badge registered to the Kingdom of the East for the Order of the Tygers Combattant ("Per pale Or and azure, two tygers combattant counterchanged."). Two differences are required between pieces of protected armory for registration and in this case there is only one for the difference between the lion and the tyger as the two are not considered substantially different.



## Girard le Bourguignon and Guenièvre de Monmarché. Badge.

(Fieldless). A cross fleury purpure. Unfortunately, the Laurel Office returned the badge for conflict with that of Oriana of Ely ("(Fieldless) A cross of Calatrava purpure.") which was registered in November, 2004, two months after Atlantia submitted this to Laurel. Two differences are required between pieces of protected armory for registration and in this case there is only one for the theoretical difference between the fields as a cross of Calatrava is considered to be a variant of a cross fleury.

Saige inghean Ghiolla Phádraig. Name. When this was submitted at Pennsic, there was some thought that the standing precedent against mixing Welsh and Gaelic could be overturned and this was submitted as a test case. Unfortunately, such evidence was not presented so the name was returned on the basis of the existing precedent.

**Timothy of Shaftesbury.** Device. Gules, five arrows in arch and a mount Or. Unfortunately, the Laurel Office returned the device because they considered that the arrows were not "in pile" but were "in arch" which has been banned for some time by precedent.

**William Thomas.** Name. Unfortunately, the Laurel staff felt they had to return this name for conflict with William Thomson who established the Kelvin scale for measuring temperatures and was known at times at Lord Kelvin.
