
The Laurel Office has notified us of the results of its considerations at the meetings in April, 2006. These results were conveyed in a letter received in Atlantia on 20 July, 2006.






Beatrix von Leipzig. Device. Pily bendy ermine and gules.


**Cassie Charlesworth.** Name. *Cassie* is the submitter's legal given name.



Christina de Nedham. Device. Gules, a chevron couched from dexter Or.




**Donal macRuiseart.** Badge. (Fieldless) A cross of four anchors conjoined at the ring Or.




**Ekaterina Filippiia.** Device. Per bend sinister azure and argent, a monster with the forequarters of a pegasus and the hindquarters of a dragon sejant erect counterchanged. She has permission to conflict with Sabine Berard ("Per bend sinister azure and argent, a dragon segreant counterchanged maintaining in its sinister claw a bezant.")




**Esa Kirkepatrike.** Device. Gules, a goblet between three hounds courant in annulo widdershins Or.




**Griffith Jenner.** Device. Sable, a wall issuant from base argent masoned and portalled sable and in chief three A-frame plumb lines Or.




**Iseulte of the Red Cliffs.** Badge. Checky argent and sable, on a lozenge gules a dragonfly argent.


**Maeve FitzRobert of York.** Device. Per bend azure and sable, on a bend wavy between two increscents argent, three suns azure.




Marie Hélène of the New Forest. Name and device. Argent, in pale two winged cats courant countercourant sable.




**Maura von Blitzbau.** Device. Azure, on a pale doubly endorsed argent five saltires gules.




Olivier de Bayonne. Device. Gules, three astrolabes and a chief argent.




**Owen Sherard Trahern.** Device. Or, a winged spear and on a chief sable three lions couchant argent.




**Philip ap Mereduth.** Device. Per pale gules and sable, on a pale Or three estoiles gules.




**Rhys Cantor.** Device. Argent, a chevron embattled vert between two mullets of eight points and a fox rampant gules.




**Ro von Rheinfranken.** Name and device. Argent, a cock vert within a bordure raguly azure.

She has released her device ("Per saltire argent and azure, a sun counterchanged and on a chief azure three escallops inverted argent.") registered in February, 2001.




Sunniva Kyrre. Badge. (Fieldless) A compass star voided azure.




## **RETURNS:**

The following items were RETURNED by the Laurel Office:


Maura von Blitzbau. Badge. (Fieldless) A mushroom vert. The Laurel Office felt that as drawn, the cap of the mushroom made the charge as a whole look too much like a tree, creating a visual conflict with the protected arms of O Connor Don ("Argent, a tree eradicated vert."). They suggested that if this were redrawn so the mushroom cap were definitely flat on the bottom and only slightly rounded on the top, the charges would be distinct enough to remove this visual conflict.



Minowara Kiritsubo. Change of augmented device. Sable, an annulet surmounted by three dragon's claws in pall inverted conjoined at the tips argent between, as an augmentation, in fess two coronets and in pale in annulo an Oriental dragon passant to sinister and another passant inverted Or. The Laurel Office returned this on technical grounds as the Laurel Office now requires that the underlying arms and the augmented arms be modified separately if there is a change to the underlying arms as well as the augmentation. As the emblazon sheet for the underlying arms did not match that in the Laurel files, they returned the entire submission so that separate paperwork could be submitted for the underlying arms or that the new augmented arms could be redrawn using a depiction of the underlying arms that matches that in the Laurel files.



**Phillip of Ghent.** Change of device. Per chevron argent and vert, two fir trees eradicated vert, each charged with a coronet, and a hawk stooping argent. The Laurel Office returned this for redrawing because they felt that the line of division was too low for a per chevron line of division but too high for it to be a point pointed. As the emblazon apparently did not match the emblazon for his previously registered arms, which were identically blazoned except for the coronets, the Laurel staff felt this could not appeal to the "Grandfather Clause" which protects armorial elements previously registered for a submitter.
