


The Laurel Office has notified us of the results of its considerations at the meetings in September, 2006. These results were conveyed in a letter received in Atlantia on 27 December, 2006.

The following items were REGISTERED by the Laurel Office:


Amber Roriksdatter. Badge for Barbara of Bonei. Sable, a rabbit's head couped close argent.

Christian Thomas of York. Device. Sable, a Corinthian horned helmet affronty Or, on a chief embattled argent three fleurs-de-lys vert.




Christian Thomas of York. Badge. (Fieldless) A Corinthian horned helmet affronty Or charged with three fleurs-de-lys, one and two, vert.




Gustav Emile der Dunkele Rotvogel. Badge. (Fieldless) On a pentagon gules a martlet Or.

Miriam Calvert of Gidiehall. Change of name from Miriam Calvert of Gidiehall Honiburn.



Owain Penbras. Name and device. Vert, three serpents involved in annulo and on a chief argent three Arabian lamps lit vert.




Sajah bint Habushun ibn Ishandiyar al-Hajjaji. Badge. (Fieldless) A brown hippopotamus statant guardant proper.

Samuel Calvert of Gidiehall. Change of name from Samuel Calvert of Gidiehall Honiburn.

Thomas Saer Glamorgan. Name. The name was submitted as Thomas Saer *of* Glamorgan. The preposition was dropped from the last phrase by the Laurel staff to meet the submitter's request for authenticity.

Porsteinn sviðbalki. Name (see RETURNS for device).


Turgeis Hakonsson. Change of name from Turgeis Hákonarson (see RETURNS for badges).




RETURNS:

The following item was RETURNED by the Laurel Office:


Livia Zanna. Device. Azure, a falcon and on a chief embattled argent, three roses proper. While the submitter had permission to conflict with Lynette Jaclyn Davéjean ("Azure, a dove and on a chief argent, two roses proper."), the Laurel staff returned this for conflict with Morgan the Falconer ("Azure, a falcon displayed, belled and jessed, on a chief embattled argent three roses purpure."




Porsteinn sviðbalki. Device. Per bend azure and argent, a bend cotised between two thunderbolts, all counterchanged. The Laurel staff returned this device for redrawing with a wider space between the cotises and the bend and wider lines on the lightning portion of the thunderbolts: "The thunderbolts need to be redrawn so that the lightning bolts aren't a single thin line. As drawn, nothing except the ends of the argent lightning bolts are visible, giving the appearance of a pillar between four arrowheads."



Turgeis Hakonsson and Sunniva Kyrre. Badge. (Fieldless) In saltire four mascles interlaced argent. Because they found period examples of Bowen knots drawn with squared corners, the Laurel staff returned this badge for conflict with the protected badge of Bowen ("(Tinctureless) A Bowen knot.").




Turgeis Hakonsson. Badge. (Fieldless) In saltire four mascles interlaced azure. Because they found period examples of Bowen knots drawn with squared corners, the Laurel staff returned this badge for conflict with the protected badge of Bowen ("(Tinctureless) A Bowen knot.").



PENDS:

The following item was PENDED by the Laurel Office:

Maeve M'Encrogh. New device. Per bend invected vert and argent, a tree eradicated counterchanged. Because of a typographical error in the tinctures of the blazon on the original Letter of Intent, the Laurel staff pended this submission until the meetings of April, 2007, for further consideration by the College of Arms. Our apologies to the submitter for not catching the typographical error in time to prevent the Laurel staff from taking this action.
