
Unto the populace of Atlantia, greetings from Alisoun MacCoul of Elphane, Golden Dolphin Herald!

The Laurel Office has notified us of the results of its considerations at the meetings in February, 2007. These results were conveyed in a letter received in Atlantia on 1 June, 2007.


ACCEPTANCES:

Alan de Nedham. Name and device. Sable, a chevron couched from dexter Or. The submitter has permission to conflict with the armory of Christina de Nedham ("Gules, a chevron couched from dexter Or.").



Ansel Rowland Matthews. Device. Per chevron embattled vert and argent, a stag trippant argent and a triquetra azure.

Atlantia, Kingdom of. Name for the Award of the Alcyon.

Atlantia, Kingdom of. Change of name from Order of the Fountain to Award of the Fountain.

Atlantia, Kingdom of. Change of name from Order of the Herring to Award of the Herring.

Atlantia, Kingdom of. Change of name from Order of the Hippocampus to Award of the Hippocampus.

Atlantia, Kingdom of. Name for the Award of the Sea Tyger.


Atlantia, Kingdom of. Change of name from Order of the Sea Urchin to Award of the Sea Urchin.

Elizabet de Roslyne. Name.




Geoffrey de la Beche. Change of device. Per pale azure and gules, on a pile Or a beech tree proper.

Isabel de Nedham. Name.




Samuel Calvert of Gidiehall and Miriam Calvert of Gidiehall. Badge. (Fieldless) A cow rampant vert.




Sian verch Gwilim ap Lewelin. Name and device. Azure, a tree blasted and eradicated Or, on a chief argent three pheons sable.



Ynes Garcia. Device. Lozengy argent and sable, on a fess gules five lozenges Or.



Ysabel de la Zarza. Device. Sable, in cross four roses argent, seeded Or and barbed vert, within a chaplet of thorn Or.



RETURNS:

The following items were RETURNED by the Laurel Office:

Aislinn Blackburn. Name. The Laurel Office returned this name on technical grounds believing it to be two steps from period practice and hence not allowable for registration. Their reasoning for this was that *Aislinn* has been ruled a modern Gaelic name but "Society-compatible". They consider that the use of a "Society-compatible" name is now a step from period practice and also that the mixture of Gaelic and English (as *Blackburn* is English) is also a step from period practice. The Laurel staff specifically said that she could use a Gaelic name documented in period with *Blackburn* or could use a name that is found in an English context and sounds alike such as *Ascelina* or *Acelina*. Indeed, only the submitter's limitation on changes to then name prevented their registering it as Ascelina Blackburn.

Layla al-Mua'llima. Name. While *al-Mua'llima* was adequately documented as a period name element, the Laurel Office returned the name as a whole as presumptuous since *Mua'llima* has been officially adopted as an Arabic alternative for the peerage title "Mistress" in the Society.
