These results were conveyed in a communication received in Atlantia on the evening of 31 October, 2007.


## **ACCEPTANCES**

The following items were REGISTERED by the Laurel Office:

Atlantia, Kingdom of. Badge. (Fieldless) On an escallop Or a rose azure. This badge is intended for the Queen's Order of Courtesy. The Laurel Office ruled that that the term Queen's Order of Courtesy is not a generic identifier but an order name currently belonging solely to the Kingdom of the East. As Atlantia has been using this terminology since its first days as a daughter kingdom of the East, we are approaching the Kingdom of the East for permission to register the name with the addition of our kingdom's name.



Atlantia, Kingdom of. Association of order name Académie d'Espée and previously registered badge. Argent, a billet between two unicornate natural seahorses azure. The name was registered in October, 1993 with a badge of "Or, two rapiers crossed in saltire sable between four roses azure." In November, 2000, only the badge was transferred to Nathaniel Sharpe. Meanwhile Atlantia registered another badge ("Argent, a billet between two unicornate natural seahorses azure.") and has been using that badge for the Académie d'Espée. This action associates the registered name and registered badge.



**Atlantia, Kingdom of.** Badge for the Award of the Alcyon. (Fieldless) In pale a kingfisher rising sustaining an escallop azure.



**Atlantia, Kingdom of.** Badge for the Order of the Sea Dragon. (Fieldless) A sea dragon per fess azure and argent.



**Atlantia, Kingdom of.** Badge for the Award of the Sea Tyger. (Fieldless) A sea tyger per fess azure and Or.



**Atlantia, Kingdom of.** Badge for the Award of the Silver Osprey. (Fieldless) A sword palewise Or between and sustained by two ospreys rising respectant argent.




**Crestienne Chabrier.** Device. Azure, a dragon's head erased Or and on a chief invected argent, three spools of thread vert.

Erik Olafssen. Name.

Khadir bar Yosef ha-Kuzari. Change of name from Muirghen Ruadh.

Líadan ingen Fháeláin. Name.





Marinus, Barony of. Badge for Scriptorium Marini (see RETURNS for guild name). Per pale vert and azure, an open scroll and on a chief argent a quill pen fesswise sable. While declining to register the name Scriptorium Marini on the grounds that the term scriptorium was a "generic identifier", the Laurel Office felt that it was acceptable in Latin as such an identifier and therefore associated the badge with that unregistered (but still usable) generic identifier.



**Phillip of Ghent.** Change of device. Per chevron argent and vert, two fir trees eradicated vert, each charged with a coronet, and a hawk striking argent.


**Stierbach, Barony of.** Order name for the Award of Saint Roch.






**Tessa de Spina.** Name and device. Per saltire azure and vert, a saltire and in chief a dragonfly argent.

Thomas of Chester. Name.




**William of Wolverhampton.** Device. Sable, on a chief embattled Or three arrows fesswise gules.




## **RETURNS**

The following items were RETURNED by the Laurel Office:


**Atlantia, Kingdom of.** Badge for the Award of the Fountain. Argent, goutty, a bordure wavy azure. The Laurel Office returned this badge for conflict with Deborah di Carnevale ("Argent, goutty de larmes, a bordure nebuly vert.") as they ruled that no difference is allowable between a bordure wavy and a bordure nebuly.



**Gwyneth MacDonagh.** Device. Per pale wavy Or and purpure, a greyhound courant contourny counterchanged. The Laurel Office returned this for conflict with Conrí Mac Eógain ("Per pale Or and purpure, a wolf statant to sinister counterchanged.") since they ruled that the width of the hound at the point where the line of division fell was too narrow for the wavy line of division to be readily identified so it could be mistaken for a plain per pale line of division.



Gwyneth of Avondale. Device. Per chevron sable and Or, three decrescents one and two Or and a goblet sable. The Laurel Office returned this device because they perceived a disparity between the rendition of the line of division between the colored emblazon sheets in the Laurel files and the line drawing in the on-line letter of intent system. (Many submissions from several kingdoms were returned for this reason in July, 2007.) The Golden Dolphin Office is addressing this issue and will resend the submission out to Laurel on the November Letter of Intent.



Marinus, Barony of. Guild name for Scriptorium Marini. The Laurel
Office ruled that the term scriptorium was a "generic identifier" and that the
addition of the name of the barony did not change this status. While
declining to register the name, the Laurel Office did use it as an identifier for the badge proposed for
association with the submitted guild name, saying "As a generic designator, the name is not registerable,
but it can be used to identify the purpose of a piece of armory as in this case."
