
Herein you will find the results of the deliberations of the College of Heralds of Atlantia during the month of March, 2008.

Deborah Aurifex. Name (see RETURNS for device).


Dunecan de Brus. Name and device. Per bend Or and azure, two lions couchant counterchanged.



Elena Modarova vnuka. Name and badge. (Fieldless) On an apple argent, a cinquefoil sable.




Jean Claude de Lyon. Device. Gyronny gules and Or, a ram courant argent between in pale two fleurs-de lys counterchanged.



Mahaut de la Mare. Name and device. Ermine, a coney courant gules and on a chief sable three crescents argent.



Merwenna Maycock. Name (see PENDS for device).




Milicent Shiveley. Device. Azure, a lion sejant maintaining a lily Or, slipped vert, between three crescents argent.




Rita de Tacoronte. Device. Per pale argent and vert, in pale two lions couchant sable.


Salvatore Agnoli. Name. The surname appeared on the forms as Agoli, but examination of the documentation and period documentation. Since the submitter allowed all changes to the name we have changed the surname to the documented period form.



Sian verch Gwilim ap Lewelin. Badge. (Fieldless) A tree blasted and eradicated bendy argent and azure.




Tegrinus de Rhina. Device. Quarterly argent and gules, in fess two pairs of swords inverted in saltire sable.




Thyre of Andovere. Change of name and change of device. Counter-ermine, a chevron Or ermined gules.

Timmeke Haakonson of Nordheim. Release of badge. Per fess gules and sable, a double-bitted axe argent.




Wistric Oftun. Device. Per pale azure and Or, six Wake knots two two and two counterchanged.




RETURNS

The following items have been returned for further work:

Brigid Ein Tiarnán. Name and device. Per pale Or and vert, in saltire two quill pens and on a chief three trefoils counterchanged. No documentation could be found for the use of "ein" and a nominative in Irish for a patronymic. As the submitter allowed all changes to the name, it could have been changed to middle Irish Brigit ingen Thigernáin or early modern Irish Brighid inghean Thighearnáin. Unfortunately, both of these conflict with the registered name of Brigit ingen Thighernáin. As there is no registerable name, the device must be returned as well. Even if this were not the case, the device would have had to be redrawn to make the chief wider and the quill pens more identifiable..



Deborah Aurifex. Device. Argent, on a pile between six gemstones azure a chasing hammer Or. The device must be returned for conflict with Arianna Chiara Fiorucci ("Argent, on a pile between six gemstones azure, a unicorn rampant argent.").




Óengus Gilla Críst. Name and device. Per pale sable and vert, a bull rampant maintaining a mug argent. The name must be returned since Laurel has ruled against the use of unmarked patronymics in period Irish so that we would have to add a patronymic particle like *mac* before the *Gilla Críst* here. Since adding the patronymic particle would exceed the changes the submitter would allow, we were compelled to return the name. As there is no registerable name, the device must be returned as well. Since several commenters felt the beast resembled a ram or some other heraldic beast more than a bull, we are asking the submitter to redraw the primary charge in a more standard manner.




PENDS

The following items have been pended for the stated reasons:

Merwenna Maycock. Device. Per fess embattled Or and gules, in pale two cocks counterchanged. Since there was some confusion as to the tinctures the submitter had requested at the consultation table where she submitted, this has been pended for consultation with the submitter.



Vladimir Krisa Tirgovishtets. Device. Quarterly sable and azure, in pale two rats counterpassant argent. The submitter indicated that he wished his rats to be passant rather than statant and the depiction used here was traced from a piece of armory previously registered through another kingdom. However, commentary expressed enough doubt about the identifiability of the posture and the nature of the charge that we are pending this to allow a better heraldic artist to redraw the rodents in a manner more likely to satisfy the College of Arms.
