
Unto the populace of Atlantia, greetings from Alisoun MacCoul of Elphane, Golden Dolphin Herald!

## **ACCEPTANCES**

The following submissions have been accepted and included on a Letter of Intent to the College of Arms from Atlantia dated 28 February, 2009:

**Achbar ibn Ali.** Badge. Argent, on a fess vert a doumbek between two crescents argent.



**Agnes Daunce.** Change of device. Or, a ewer azure and on a chief gules a staff fesswise Or wreathed sable.

Angus of Bedford. Name (see RETURNS for device).


Elyas Atwode. Name (see RETURNS for device).




**Esa Kirkepatrike.** Change of device. Gules, a goblet between three hounds courant in annulo Or.

Giovan Donado. Change of name from Giovan Donato Falconieri.


**Hidden Mountain, Barony of.** Order name for Order of the Green Mountain.




**Hidden Mountain, Barony of.** Badge for the Award of the Azure Cloud. Per chevron argent and azure, two clouds azure.




**Hidden Mountain, Barony of.** Badge for the Award of the Crimson Cloud. Per chevron argent and gules, two clouds gules.




**Hidden Mountain, Barony of.** Badge for the Award of the Silver Cloud. Per chevron sable and Or, in chief two clouds argent.



**Johanna von Sudeborn and Richard Wyn.** Badge. Sable, a pair of shears argent within an annulet Or. If registered, this should be associated with the name Southwin Lodge, registered through Atlantia in February, 2006.




**Katheryn M'Kethirryke.** Change of device. Per chevron azure and argent goutty de sang, two wolves combatant and a chief fleury argent.





**Logan Blackwoulfe.** Change of device. Quarterly gules and argent, a wolf rampant reguardant sable, crowned Or, between four crescents in saltire counterchanged, a bordure embattled sable.

**Magdalene de Hazebrouck.** Change of name from Magdalena de Hazebrouck.


**Magdalene de Hazebrouck.** Release of alternate persona name Madeline Flemyng.








**Mungo Napier.** Name and device. Gules, a duck close contourny head elevated and on a chief argent three pheons inverted gules.




**Sara Sinclair Napier.** Name and device. Azure, a duck naiant head elevated and on a chief Or three pheons inverted gules.



**Segehart von Leitmeritz.** Name and device. BendyOr and vert, a seagoat within a bordure argent.

**Wil Elmsford.** Transfer of name and armory to Ysolt la Bretonne by inheritance. Vert, a unicorn's head couped between three quatrefoils barbed argent. Wil was the legal son of Ysolt and she was his legal heir at the time of his recent death.

**Ysolt la Bretonne.** Transfer of name and armory from Wil Elmsford by inheritance. Vert, a unicorn's head couped between three quatrefoils barbed argent. Wil was the legal son of Ysolt and she was his legal heir at the time of his recent death.




**Ysolt la Bretonne.** Release of armory. Vert, a unicorn's head couped between three quatrefoils barbed argent.


## **RETURNS**

The following items have been returned for further work:

Angus of Bedford. Device. Chequy argent and gules, two boars rampant addorsed tails nowed sable and on a chief embattled Or three battle axes bendwise sinister blades to sinister gules. Unfortunately, this has to be returned because it was impossible to come up with a blazon that adequately guaranteed the reproducibility of the position and interrelation of the tails as simply using "nowed" does not fully describe the tails. While this is a relatively minor detail of the overall design, it is required that any such elements be reproducible solely from the blazon and this is not. Were the tails entwined in a more standard manner or nowed following one of the standard knot patterns, the reproducibility issue would go away. When resubmitting, it might be advisable if the submitter used fewer and larger divisions on the field.



Christoph Von Krieg. Name and device. Azure, a panther rampant Or spotted sable incensed argent collared and chained argent within a bordure dovetailed Or. The name had to be returned since no documentation was provided or could be found for any period surname that used both *von* and *Krieg*, although there is a period surname *Krieger* with a similar meaning. We would have submitted the name Christoph Krieger, but the submitter allowed only minor changes to the name. The device must be returned for conflict with Robert of Cundiff ("Azure, a Continental panther rampant guardant within a bordure rayonny Or.). When resubmitting, the submitter is strongly advised to use fewer and larger dovetails if he retains the dovetailed bordure.




**Elyas Atwode.** Device. Azure, a fox rampant per fess Or and argent. Unfortunately, this lovely device conflicts with that of Junella merch Beli ("Azure, a wolf rampant ermine maintaining a rose slipped and leaved Or.").


**Hidden Mountain, Barony of.** Order name for Order of the Blue Mountain. Unfortunately, this name has to be returned for conflict with the heraldic title of Blue Mountain Pursuivant registered to the Barony of Dreiburgen in Caid.

**Isabella the Cloud Gazer.** Name and device. Argent, a penguin proper within a bordure pean. No documentation was provided for the byname as following a period pattern for English bynames nor for the particular words existing in period as required by current standards. We found *Godesman Gase* dated to 1232 and *Richard atte Cloude* dated to 1327 which would support a name like Isabella Gase atte Cloude in period. However, the submitter limited changes to the name so the name as a whole must be returned. As the penguin has a white belly and feet lying on the argent portion of the field, by Laurel precedent this must also be returned for violating our rules on contrast.

Talitha of Avalon. Device (see PENDS for name). Per fess argent and gules, three bars sable and a nightingale contourny argent. Unfortunately, since by precedent the upper portion of the field could be parsed as barry argent and sable and, if it is, the movement of the argent bird to base is forced, this conflicts with Rannveigr Haakonardottir ("Azure, a falcon close contourny argent.").







## **PENDS**

The following items have been pended for the stated reasons:

**Alisoun MacCoul of Elphane.** Acceptance of transfer of heraldic title Metron Ariston Herald from the Kingdom of Atlantia. Pended due to changed requirements for transfer documents in the new *Administrative Handbook*.

**Atlantia, Kingdom of.** Transfer of heraldic title Metron Ariston Herald to Alisoun MacCoul of Elphane. Pended due to changed requirements for transfer documents in the new *Administrative Handbook*.

**Leviathans Cove, Canton of.** Name and device. Per bend sable and azure, a wingless sea dragon naiant bendwise and in sinister chief a laurel wreath argent. This submission has to be pended because the promised petition of support revised to meet the requirements of the College of Arms has not been received by the Golden Dolphin Office. (The original petition did not include an adequate description of the armory.)

**Talitha of Avalon.** Name. As there were issues with the biblical documentation provided by the submitter for the given name *Talitha*, this has been pended to await the arrival of the promised proof that the submitter's legal given name is indeed *Talitha*.
