The following submissions have been accepted and included on a Letter of Intent to the College of Arms from Atlantia dated 30 March, 2009:


Aldyth the Gentle. Name and device. Per bend sinister argent and azure, a crab vert and an eagle argent.


Aleit de la Thomme. Change of name from Tamsin Longshanks (see PENDS for device).

Beata Lyndon of Taylorwood. Device. Per pale vert and argent, a tree couped and on a chief three seeblätter counterchanged.

Derbáil ingen Lonáin. Badge. (Fieldless) In pale a reremouse displayed sable sustaining in its claws an ankh Or.

Glaukos the Athenian. Change of name from Rowan of Needwood (see RETURNS for device).







Lillian Hawkins. Name.

Ormr Hjálmólfsson. Name (see RETURNS for device).

Philip ap Griffith. Badge. (Fieldless) A fess couped balanced upon the point of a triangle sable.

Hroði Hrólfsson. Name.


Sorcha inghean Eachrain. Name and device. Per fess Or and per pale gules and azure, in pale a demi-sun sable and a sheaf of spoons, bowls to chief, Or.


Talitha of Avalon. Name. This was pended by Golden Dolphin in February, 2009, for further documentation. That documentation has now been provided.


RETURNS


The following items have been returned for further work:

Glaukos the Athenian. Device. Purpure, an owl close to sinister argent. Unfortunately, we had to return this lovely device for conflict with the badge of Safiya bint Nasr al-Samiriyya ("Purpure, an owl stooping argent.") as only one difference is allowed for multiple changes of posture/orientation.












Ormr Hjálmólfsson. Device. Per pale azure and Or, two dragons combatant counterchanged argent and gules. Unfortunately, this must be returned for conflict with Isaac Wolfstan ("Per pale azure and Or, a dragon argent and a dragon vert combattant, each maintaining a sword, the swords crossed in saltire argent.") as no difference is allowed for the maintained swords.



PENDS


The following items have been pended for the stated reasons:


Aleit de la Thomme. Device. Vert, a lion dormant to sinister and a chief enarched argent. Unfortunately, we had to pend this armory because we have not yet received the promised letter of permission to conflict from her mundane father, Thomas Longshanks, whose armory ("Azure, a lion dormant to sinister and a chief arched argent.") differs only by the tincture of the field.


Brynjolf rauðskegg. Name and device. Argent, a brown bear's head erased proper and a chief embattled sable. We have pended the name to consult with the submitter as he indicated he wanted a "Viking" name and it would appear that a more likely Old Norse version of the name would be Brynjólfr rauðskeggr rather than the submitted form. By the same token, the emblazon sheets had not only the fur but also the tongue and the teeth of the bear brown. That does not occur in nature or any defined heraldic "proper". Moreover, as drawn the head was not readily identifiable as a bear's head. Finally, the embattlements on the chief were relatively shallow. Each of these problems require a redrawing of the device.

Cerball mac Donndubáin na hInnsi. Name. Since the forms were not clear on this point, we have pended this to confirm with the submitter that he wishes the byname "of the Island" to apply to his father, as it does in the submitted form, or to himself in which case the name should be Cerball na hInnsi mac Donndubáin.

Cormacc ua Néill na Moicheirghe. Name and device. Azure, two wings conjoined in lure and on a chief argent three lozenges azure. We have pended this to allow us to consult with the submitter as to whether he intended the byname *na Moicheirghe* to apply to his father, as in the submitted form or to himself in which case the name should be Cormacc na Moicheirghe ua Néill. Since the name has been pended, the armory must be as well.







Godric Lynchemere. Name. We have pended this name to consult with the submitter because he requested authenticity. By his own documentation, the given name *Godric* appears to have died out in common use by the thirteenth or fourteenth century while the spelling of the byname submitted cannot be dated before the sixteenth century. We believe the name is registerable as it is, but the Laurel Office is likely to change the byname to an earlier form to meet the request for authenticity. To allow the submitter better control over any changes, we have asked him whether he wished to use an earlier form of the place name like *Wlenchemere* or whether he wishes to drop the request for authenticity and retain the submitted sixteenth century form of the byname.

Judeke von Adebar. Name. We were able to document the given name to Groningen in 1469. However, although the submitter was under the impression that Adebar was a place name that could be used with the preposition von, in fact it appears to be a derived from the German word for a stork. We found *Joh. Adeber* from 1426 and *Slacke Adebor* from 1558 so Judeke Adeber or Judeke Adebor would appear to be fine. We have pended this to ask the submitter whether either of those forms would be acceptable to her.
