
Unto the populace of Atlantia, greetings from Alisoun MacCoul of Elphane, Golden Dolphin Herald!

The following submissions have been accepted and included on a Letter of Intent to the College of Arms from Atlantia dated 29 April, 2010:


Alexandra Gangefeyr. Device. Per bend flory counterflory Or and sable.




Griffinsdale, Canton of. Name and device. Quarterly azure and sable, a griffin segreant within a laurel wreath Or.




Halfdan bekkjarbrjótr. Device. Per saltire sable and vert, a deer's head cabossed within a bordure argent.




Jamila bat Hayyīm, Device. Purpure, on a chevron Or between an increscent, a decrescent and an elephant trumpeting argent three stars of David azure. This was pended by Golden Dolphin for redrawing in March, 2010.




Mungo Napier. Device. Gules, a duck close contourny argent billed and membered Or, on a chief argent three pheons inverted gules.




Murienne l'aloiere. Device. Gules, three furisons sable. The submitter appealed to a Regional Style Exception for German regional style to allow this submission to violate the portions of the Society's heraldic regulations requiring good contrast between the field and any charges which lie on it.



Oda Wlslagre dicta Widoeghe. Name and device. Gules, a jacob sheep rampant argent spotted sable and in chief a comet fesswise Or. The name was submitted as Oda Wislagre dictus Widoeghe While the forms had the byname as *Wislagre*, the *i* appears to be a misreading of a "1" in the documentation. We have therefore corrected the name to the documented form *Wlslagre*. The name also had the Latin byname connective in the masculine form *dictus*. With the explicit permission of the submitter we have modified this to the appropriate feminine form *dicta* to agree with the feminine given name.




Óengus mac Gilla Crist. Device. Per pale vert and sable, a bull rampant to sinister within a bordure argent.



Sara Sinclair Napier. Device. Azure, a duck naiant Or, billed proper, on a chief argent three pheons inverted azure. This was pended by Golden Dolphin in March, 2010, for consultation with the submitter.

Weyland Underwood. Name (see RETURNS for device).

Yitzchak of Marinus. Name.





RETURNS

The following items have been returned for further work:

Cailin mac Cainnig. Name and device. Azure, in cross four plates each charged with a die azure marked argent. Unfortunately, the name must be returned for conflict with the registered name of Colin McKenna. The Laurel Office has previously returned the names of Cailin mac Cainnich, Cailin MacKinnon and Cailin Mac Kinnach for conflict with that name and, while the spelling is different, the sound of the name differs in no greater degree from that of Colin McKenna. Since the name was returned, the device must be returned as well for lack of a registerable Society name.


Halfdan bekkjarbrjótr. Device. Gyronny sable and vert, a deer's head cabossed within a bordure argent. This submission was withdrawn by the submitter in favor of the device which appears above under acceptances.







Laura de la Moore. Name and device. Vert, on an open scroll within an orle Or a harp vert. Unfortunately, the name must be returned for conflict with the registered name of Lora Moore. The given names are pronounced identically and the bynames *de la Moore* and *Moore* are equivalent as they directly parallel one of the examples for equivalent locative bynames in the Rules for Submissions: "*Undertheclyf* is equivalent to *del Clif* and *Cliff*". The device has to be returned for lack of a registerable Society name, but would have had to be returned in any case or at the least redrawn because of problems with the depiction of the "orle" in both the black and white and color copies of the emblazon.

Weyland Underwood. Device. Per bend sinister vert and azure, a bend sinister between a die and a tree argent. This must be returned for conflict with the badge registered to Alys Wallas and Cydrych Wallas ("Per bend sinister vert and azure, a bend sinister between a thistle and a tower argent.")





William le Younger. Badge. (Fieldless) A cross patonce with its lower arm replaced by a capital letter "w" gules. This must be returned for lack of documentation from period of such a conjoining where the entire lower arm of a complex cross is replaced by a letter as it is here. Additionally, since similar san-serif letters have been returned for non-period style in the past, some documentation for this particular form of letter in period would also be advisable. There were also some concerns about the identifiability of the cross when the entire lower arm is subsumed by the letter here.



PENDS

The following item has been pended for the stated reasons:

Porgautr inn vikverski. Device. Sable, in pale a Thor's hammer inverted and a Thor's hammer argent within a bordure Or. This has been pended for redrawing with the primary charges more centered on the shield and for consultation with the submitter as to whether or not he really intended the Thor's hammers to be conjoined.
