
Unto the populace of Atlantia, greetings from Alisoun MacCoul of Elphane, Golden Dolphin Herald!

Herein you will find the results of the deliberations of the College of Heralds of Atlantia during the month of June, 2010.


ACCEPTANCES

The following submissions have been accepted and included on a Letter of Intent to the College of Arms from Atlantia dated 28 June, 2010:


Aaron of Moorhaven. Device. Checky azure and Or, a bear rampant within an orle argent.




Iain mac Donnchaidh. Device. Argent, on a cross between two pairs of lions combatant gules a cross bottony Or, on a chief gules three caducei argent.




Sean Mac Griogair. Badge. (Fieldless) A mullet of eight points pierced within an conjoined to an annulet Or. He has written permission to conflict with the badge of Walter de Witte for House De Witte ("Sable, a compass rose Or.").



Talia de Messina. Name and device. Argent, a winged hound sejant and on a chief vert three crosses formy argent.



Tigernan Mear mac Riatai. Device. Per pale argent and gules, a natural tiger's head cabossed, marked, counterchanged within a bordure embattled sable.




RETURNS

The following items have been returned for further work:

Bonaventura da Castelfranco. Badge. Argent, a mushroom azure, cap spotted argent. As the fields are identical, this conflicts with the badge of Deirdre Marianne Steele of Cowdray ("Argent, a mushroom capped per pale purpure and Or and stemmed per pale Or and purpure.") It should be also be noted that the fact that some of the argent spots lie against the argent field might be problematical given some recent Laurel returns for maintained charges or charge details (e.g., the tail of a fox) being argent against an argent field. If the argent field is retained in a resubmission, the spots should be drawn so that none of them lie directly against the field.

Eiríkr Pórisson. Device. Quarterly sable and gules, a wolf's head cabossed between eight anchors in annulo and on a chief argent in saltire two swords, that to dexter gules and that to sinister sable. Withdrawn at the request of the submitter.






PENDS

The following item has been pended for the stated reasons:

Agnarr Gunnarsson. Name and device. Per fess gules and sable, two dragons combatant wings displayed and a dragon dormant argent. Since the opinion of commenters on whether this name conflicted with the registered name of Ragnarr Gunnarsson was mixed and Laurel precedent is also mixed, we have pended this name to explore the possibility of obtaining permission to conflict from Ragnarr and to enquire of the submitter whether he wishes us to send the name to the College if such permission cannot be obtained. Even had the name not been pended, we would have pended the device for redrawing with a more standardized depiction of a dragon dormant in view of the concerns expressed by commenters on the identifiability of the dragon in base.
