

Angus Arnott. Name.


**Caitriona de Wales.** Name and device. Vert, on a cross between in bend two masks of comedy and in bend sinister two masks of tragedy argent in pale two arrows gules.




**Cassandra Arabella Giordani.** Badge. (Fieldless) A spider within and conjoined to an annulet argent.

Henry Weyland. Name.

Jane Alexandria FitzPatrick. Device. Per chevron vert and azure, a chevron Or between three sunflowers proper.





**Katherine O Tiernan.** Name and device. Purpure, three roses argent within a bordure Or. The name was submitted as Katherine Tiernan and modified to a documented anglicized Irish form of the byname in accordance with her request for authenticity for "Irish or Scot" culture.


**Maaline Renard.** Change of name from Metylda the Cunning. As the only instance we could find of this given name dated to 1292, we were unable to meet her request to make the name authentic for sixteenth century France.


Margalide de Clary. Device. Per bend sinister azure and argent, a sea lion counterchanged.






**Porgautr inn vikverski.** Device. Sable, in pale a Thor's hammer inverted and a Thor's hammer conjoined argent within a bordure Or. This submission was pended by Golden Dolphin in April, 2010, for


Vincent d'Orleans. Device. Azure, a goose close Or and on a chief argent a fleur-de-lys azure.


**Vladimir Ivanovich Aleksandrov.** Change of device. Per chevron gules and argent, two otters combattant and another rampant to sinister, all maintaining glaives, counterchanged, each otter crowned Or. The submitter is entitled to the use of the crown in his armory, the rank of count having been bestowed upon him at Coronation on 10 April, 2010.

**Vladimir Ivanovich Aleksandrov.** Change of augmented device. Per chevron gules and argent, two otters combattant and another rampant to sinister, all maintaining glaives, counterchanged, each otter crowned Or, for augmentation, a unicornate natural seahorse erect contourny maintaining in its tail a lance and pennon Or between the otters in chief. The submitter is entitled to the use of the crown in his armory, the rank of count having been bestowed upon him at Coronation on 10 April, 2010.









## RETURNS

The following items have been returned for further work:

**Clare Dupré.** Device. Vert, a winged wolf sejant ululant, on a chief Or a rose fesswise gules slipped and leaved vert. Laurel precedent states that the *ululant* posture is not registerable for other than canines and, even for canines, is a step from period practice. Laurel has also ruled that garden roses are a step from period practice. As the rose here is a garden rose and the wolf is clearly in the ululant posture, either of which would be allowable in isolation, this device must similarly be returned for being two steps from period practice.

**Ivarr Thorgislsson.** Change of device. Azure, a chevron rompu between two dragons displayed respectant and a caltrop argent. Unfortunately, this conflicts with Darius Cordell ("Azure, a chevron rompu between three Bourchier knots palewise argent.").

**Michael Batcok.** Heraldic title for Cokayne Herald. This submission has been withdrawn by the submitter.


## PENDS


The following item has been pended for the stated reasons:

**Tirzah Albrici.** Change of name from Tirzah MacCrudden. For the byname the submitter provided copies of two religious web pages devoted to *Magdalene Albrici* (c. 1415 - 1465) which were fairly unreliable and evidence presented by several commenters suggested that the spelling used there was not only modern but fairly different from the period rendition, different enough that we could not change it given the submitter's limitation on changes. We have pended this to try to document the submitted spelling or something similar from period sources and to check with the submitter as to what changes, if any, she would accept to the byname.
