ACCEPTANCES

The following submissions have been accepted and included on a Letter of Intent to the College of Arms from Atlantia dated 31 October, 2010:


Adalric Karl. Name and device. Sable, a saltire within a bordure argent and overall a sun Or. His name and device were pended by Golden Dolphin in September, 2010.

Afshin Darius. Household name for House of the White Crescent.

Dagfinnr járnauga. Name. The byname was submitted with an initial capital letter which we have modified to lower case in accordance with standing precedent for Old Norse names.


Emeludt Hänsler. Release of alternate persona name. She wishes to release the name Elisabeth Hänsler, which was the subject of a request for exchange of primary name and alternate persona name on Atlantia's Letter of Intent for September, 2010.

Evja Vermundardóttir. Name and device. Per pale azure and Or, two horses rampant reguardant addorsed within a bordure embattled counterchanged.




Fríða in hárfagra. Name and badge (see RETURNS for device). Gules, a tree eradicated between three dragonflies bendwise argent.

Gheile filia Aldwardi. Name. The name was submitted as Gheile filia Aldward. Since all the examples in the supporting documentation appear to place the father's name in the genitive form, we have added the genitive suffix -*i* to match the documented pattern.




Henry Bartholomew Weste. Device. Sable, a cross patonce between four water bougets Or.




Lorelei Greenleafe. Name and device. Per pale azure and vert, an arrow bendwise sinister inverted between an oak leaf bendwise and an oak leaf bendwise inverted argent. Documentary proof was provided that her legal given name is Lorelei.

Michael Batcok. Heraldic title for Gallo Canente Herald.


Rónán mac Aodha. Name.




Rose of Black Diamond. Badge for House of Rosewode. Or, a tree blasted and eradicated sable and on a chief embattled gules three hearts Or. This badge was pended by Golden Dolphin in September, 2010, for redrawing and to ascertain from the submitter whether the badge should be associated with the household name House of Rosewode which was also submitted at Pennsic and which appeared on the September Letter of Intent. The submitter has indicated that the household name and badge should be linked though the paperwork from Pennsic did not indicate this.



Rycharde Muir. Badge (see PENDS for household name). Per bend gules and argent, a greyhound passant and a lion couchant counterchanged.




Séamus mac Céin hUí Dhublaich. Device. Quarterly vert and sable, an arrow fesswise between four foxes sejant Or.



Seonaid ní Fhionn. Badge. (Fieldless) An escallop ermine ducally crowned Or. The submitter is entitled to the use of the ducal coronet having been created duchess by Olaf and Aislinn at Atlantian Coronation on 8 September, 1990.



RETURNS


The following items were returned in October, 2010, for the stated reasons:

Fríða in hárfagra. Device. Gules, a tree eradicated, on a chief argent three dragonflies bendwise sable. Unfortunately, this rendition of her device submission must be returned for conflict with the recently registered device of Hallveig knarrarbringa ("Gules, a tree eradicated and on a chief argent two ravens rising wings displayed sable." This conflict was discovered at the consult table, but unfortunately the Post-It note that a reblazon and redraw became separated from the remaining paperwork so that the original device submission appeared on the Internal Letter of Intent. This redrawing has now been completed and the correct blazon and emblazon will appear on Atlantia's Internal Letter of Intent for November, 2010. Our apologies to the submitter for this processing glitch.



Martelle von Charlottenburg and Eric von Charlottenburg.

Change of badge. Vert, an escallop inverted within an annulet of four greater and four lesser points on the outer edge Or. The original blazon, which had referred to the surrounding charge as "an annulet of eight points" did not indicate that the points were not all the same size but differed in amplitude in a manner similar to the variance in a compass star. The base charge is something between a compass star (which would have the rays meet in a sharp angle not a circle) and an annulet indented on the outer edges (which would have the rays meet in a sharp angle and have all the rays the same size) and a



compass star nowy. None of these could be supported by period sources and commentary

skewed strongly to the view that the charge was not reproducible solely from its description and recognizable solely from its appearance as required by the Society's heraldic regulations. Moreover, alternate blazons which would redraw this to "Vert, on a compass star Or a roundel vert charged with an escallop inverted Or" would violate the Society's current simplicity rules which bar charges on charges from being themselves charged.

PENDS

The following items have been pended for the stated reasons:

Cearbhall mac Aodha. Device. Sable, a bend gules fimbriated and in chief a phoenix argent. Though no problems were found with the device, as the submitter's name was returned for conflict in September, 2010, we have to pend this submission for lack of a registerable Society name.

Rycharde Muir. Household name for House of Sullivan. The submitter requested that the name be modified to make it authentic for the language, culture and time period of "Irish, preferably anglicized, 13-14th C". Unfortunately the documentation provided for the structure of the household name supported only Irish clan




name formation, which might support something like *Clann Shúileabháin*. The request for an anglicized form was supported by the existence of *O Sullivan* in Woulfe (under O Súileabháin), but that form was **not** italicized which means that it is a modern form which may not be used unless otherwise documented. Documentation **was** provided for the name *Mackragh O Sullivan* dated to 1600 - 1601. However, since the evidence for formation of anglicized Irish household names is not well-defined, it is unclear whether the appropriate anglicized form would be the submitted form or something rather different. As the options selected may significantly impact the probability of registration, we have pended this to consult with the submitter as to which option he prefers.

Temair ingen Fháelchon meic Domnaill. Badge. Per chevron vert and azure, a seawolf and in canton a compass star argent. The submitter's expressed intent was to play on a variant of her device ("Per chevron vert and azure, a wolf rampant and in canton a roundel argent. "). Commentary noted that the device was drawn with the line of division more sharply angled so that the head, upper paws and tail of the wolf were almost entirely on the vert portion of the field. While the original line of division is reasonable, if a tad high, we have pended this to redraw it more in line with the depiction on her arms to remove any appearance of the seawolf's being intended to lie entirely on the azure portion of the field.



Yngvildr Galtadóttir. Device. Per bend sinister sable and purpure, a boar rampant Or and a chief embattled erminois. Unfortunately, thanks to a transcription error on the forms from the Coronation Consult Table, the field division was drawn up as "per bend" rather than as "per bend sinister" as it was shown on the sketch on the back of an envelope which was the ultimate source for the armory. Neither Golden Dolphin nor any of the commenters caught this disparity during the commentary period, but fortunately it was caught during the last proof pass through the External Letter of Intent. In view of this omission, however, it is doubtful that the device was properly checked for conflict so it has been pended for



further review. It has already been redrawn and will appear on Atlantia's Internal Letter of Intent for November, 2010.
