



Caitriona an Beachaire-New Device *Per chevron inverted vert and azure, a bee volant and a tower Or.*




This device is being returned for redraw as per the May 2011 precedent for the drawing of the line division per chevron. "If substantially more of the charge or line appears to be on one side of the field's notional mid-line as compared to the amount on the other side, the submission will be returned for a redraw or re-design." If you draw a line at the fess line or mid line of the shield, most of the per chevron field division is above the fess line. Also the Bee needs to drawn a bit larger, as any charge should drawn to fill as much of the available space as possible.



Josson Andri de Laben - Resub Device

Azure, a chevron Or between two trefoils slipped and a lion rampant argent.



This device is a resubmission after the Laurel Sept 2013 return of "Azure, a chevron argent between two trefoils slipped and a lion rampant Or". For being in conflict with the device of Triston de Grey, "Azure, a chevron argent between three dragon's heads couped those in chief addorsed, Or". There was a DC for the change in type of secondary charges but nothing else.

Unfortunately, this device must be returned again, this time for conflict with two devices: Margarete del Mare, registered in December of 2003 (via Meridies): *Azure, a chevron Or between three towers argent*. There is a distinct change for changing the type of secondary, and Timotheos of Alexandria's : registered in February of 1996 (via the East): *Azure, a chevron Or between two open books and a unicorn rampant reguardant maintaining a quill pen argent*. There is a distinct change for changing the type of secondary.

In order to register a device, it needs to have 2 differences or 2 distinct changes from any registered device. Also the chevron needs to be drawn a little less large.
