

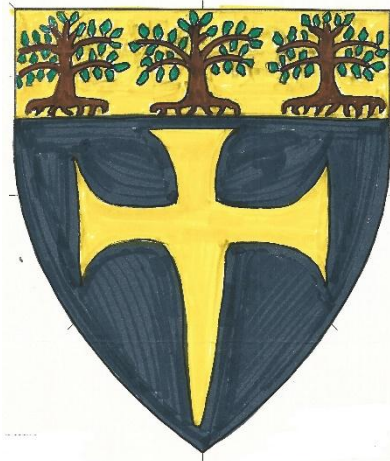
## Atlantian Letter of Decision, May 2015

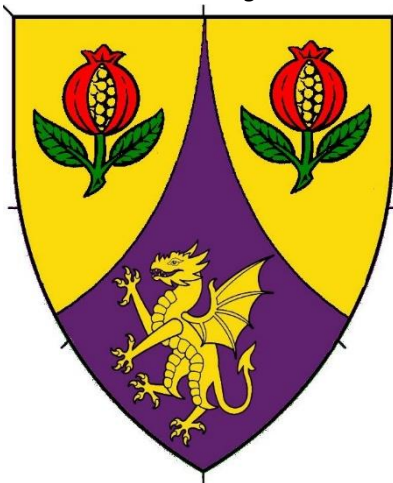

*Per chevron ployé throughout Or and purple, two pomegranates gules seeded Or slipped and leaved vert and a dragon Or.*



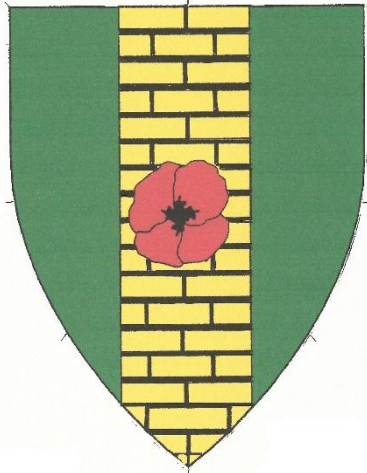

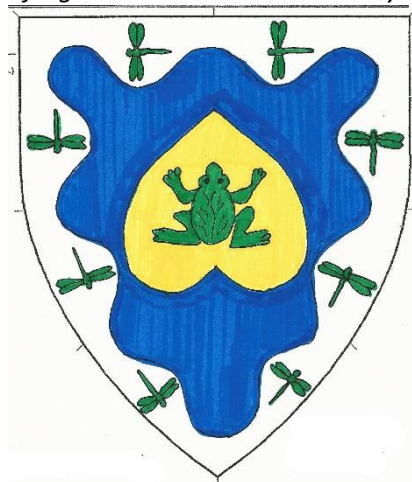
*Vert, on a pale Or masoned sable a poppy affront gules.*

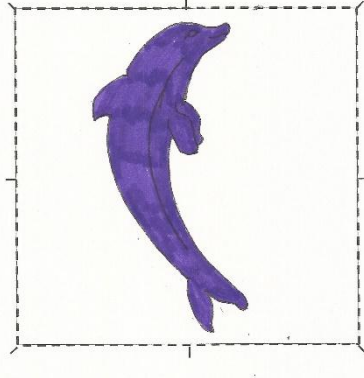

*Per chevron sable and argent, a decrescent and a wolf's head erased counterchanged.*



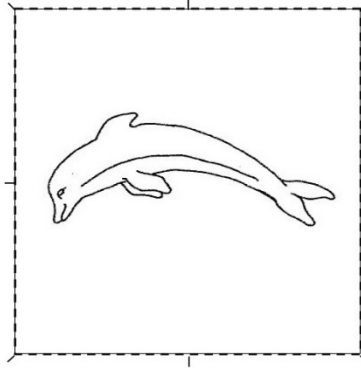

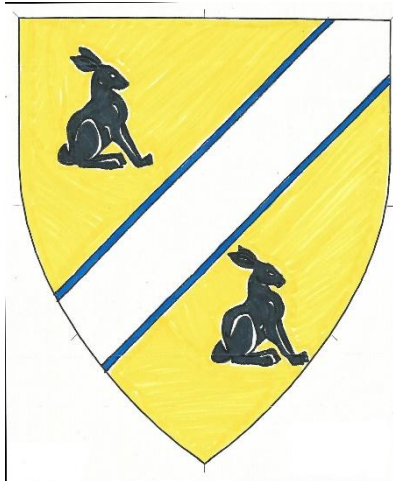

## **RETURNS**

### **Cecily Goshawke - New Device**

*Or, a bend sinister argent fimbriated azure, between two rabbits sejant contourny sable.*



This device must returned for redraw because the fimbriation is drawn too narrow and may not be considered a fimbriation. If the submitter redraws the fimbriation twice as wide as it is now, it should solve any artistic issues with the fimbriation. As of the publication of this letter of decision, the device is conflict free.

### **Hazel of Foxedene - New Device**

*Purpure, on a mountain of two-peaks couped between in chief two natural dolphins embowed respectant argent, a dragon statant regardant purpure.*

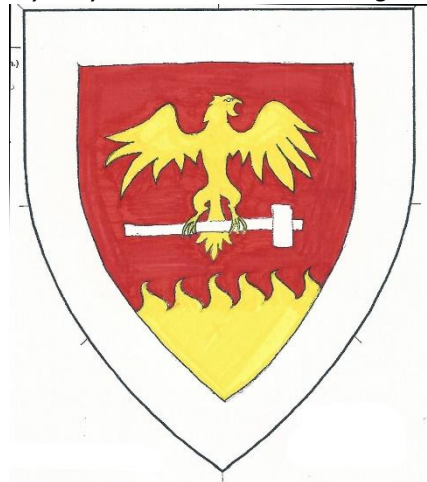


This device must be unfortunately returned for redraw because the dragon is unidentifiable, commenters mentioned that the head is hard to identify at a distance. According to SENA A.2.C.2 all elements must be drawn identifiable as it were being seen from across the field. It was suggested at the decision meeting that dragon might be more recognizable, if it has a longer neck. It was also suggested that the submitter not draw the mountain as close to the edge.

#### **Justinian of Dun Carraig - New Device**

*Gules, an eagle head to sinister Or maintaining in its talons a hammer fesswise reversed argent, a base rayonny Or within a bordure argent.*



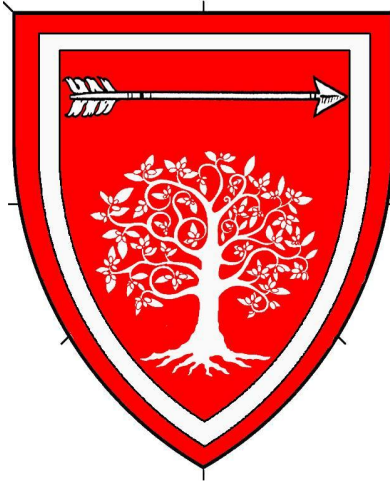
The device must be returned for redraw because the way the rayonny line is drawn as "wavy-crested" As per the February 2012 LoAR, Sibry Thorne's device "*Per bend sinister rayonny azure and gules, a crescent argent and a phoenix rising from the flames Or*" was returned because of how the rayonny line was drawn.

"The rayonny line of division must be drawn in a much more regular and symmetrical fashion, not like the long-forbidden "wavy crested" as depicted here."

**Tala al-Zahra bint Imazighen- New Device**

*Gules, within an orle, an arrow fesswise points to sinister and an olive tree eradicated argent.*

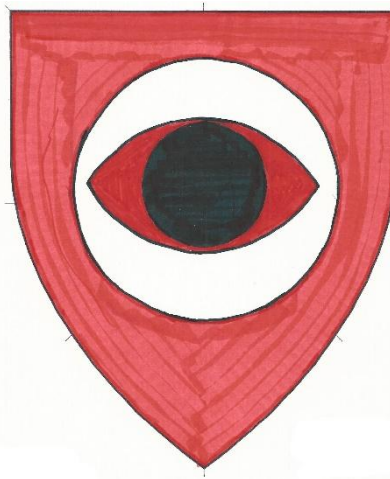


The device has to be returned for conflict with Silvanus of Cilnert, October of 1994, via An Tir "*Gules, an oak tree eradicated within an orle argent.*" There is a distinct change for adding the arrow, however there is no difference granted for an Oak tree vs an Olive tree. In order to register armory, it must have two distinct changes with any previously registered armory.

Device Consulting Herald: Etienne Le Mons d'Anjou, Vexillum Pursuivant

**Torfin blóðauga - New Device**

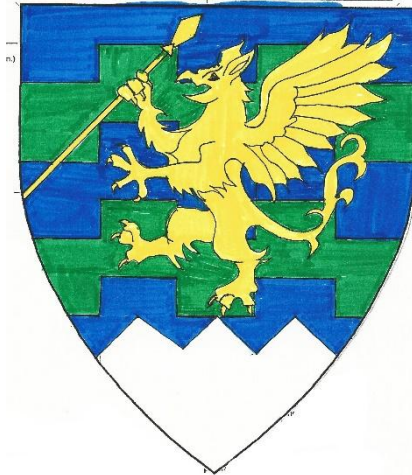
*Gules, on a roundel argent, an eye gules irised black.*



Unfortunately, this device must be returned for conflict with Edwin Bersark, registered in January, 1973 "*Gules, a roundel so drawn as to represent a round shield battered in long and honourable service, argent.*" There is one distinct change for addition of the eye as a tertiary charge. In order to be registered, a device must have two distinct changes from any registered armory. Please advise the submitter to draw the eye less like the CBS eye.

### Wrade map Wyllys map Uthor - New Name & New Device

*Barry brethesed azure and vert, a griffin holding a spear in its dexter claw bendwise sinister Or, a base indented of three peaks argent.*

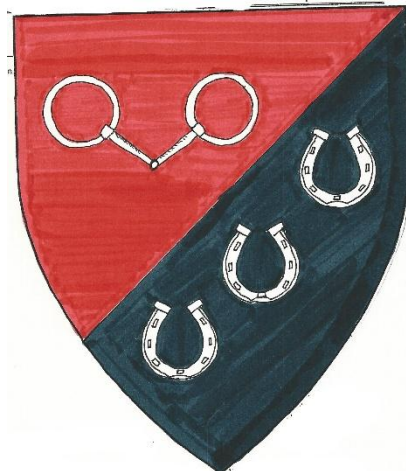
The name is being returned because the documentation provided does not match the name the submitter wants. Documentation could not be found to match the name the submitter wants during in-kingdom commentary. In order to register a name, the documentation must prove the name was used prior to 1650. Also the structure of the name must be documented as used prior to 1650.

The Device must be returned because the name is being returned. In order for a device to be registered it must have a registered name or name in progress to attach to it. The device is also being returned for a style issue. Fields divided into more than four part, must have good contrast. Azure and Vert do not have good contrast.

### Mór ingen uí Dochartaich - New Device

*Per bend sinister gules and sable, a broken snaffle-bit inverted and three horseshoes inverted argent.*
