

# Atlantian Letter of Decision, July 2015

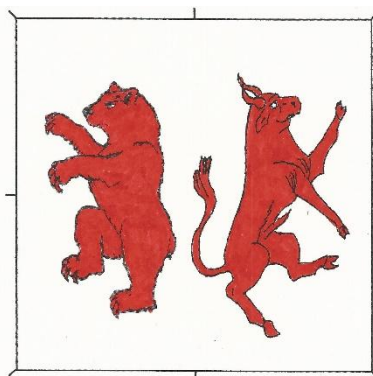

*Vert, a compass rose, in chief a roundel argent between a decrescent and an increscent Or.*



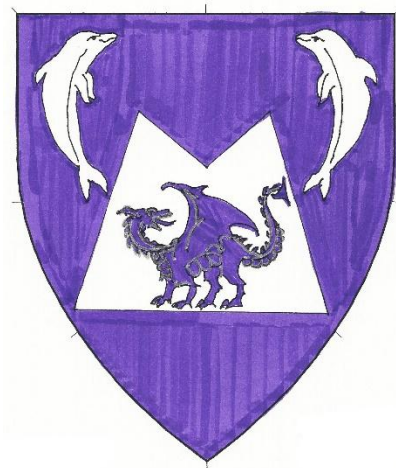

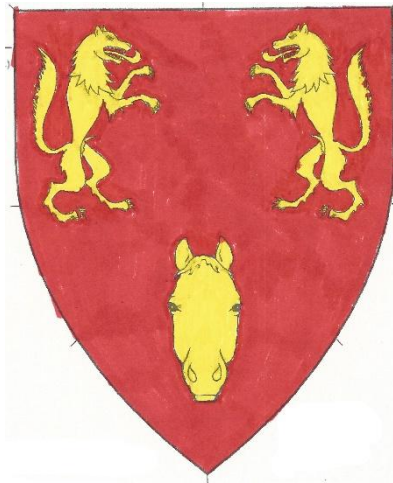
"This device was returned for redraw because the dragon is unidentifiable, commenters mentioned that the head is hard to identify at a distance. According to SENA A.2.C.2 all elements must be drawn identifiable as it were being seen from across the field. It was suggested at the decision

meeting that dragon might be more recognizable, if it has a longer neck. It was also suggested that the submitter not draw the mountain as close to the edge."

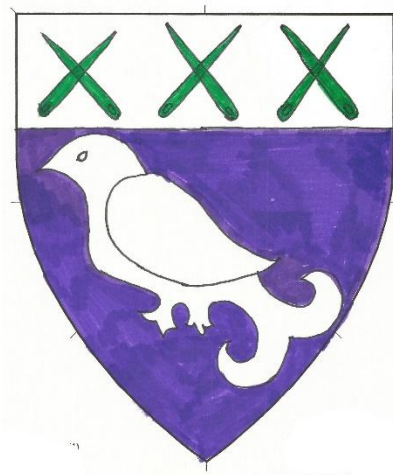
*Gules, two wolves combattant and a horse's head affronty Or.*

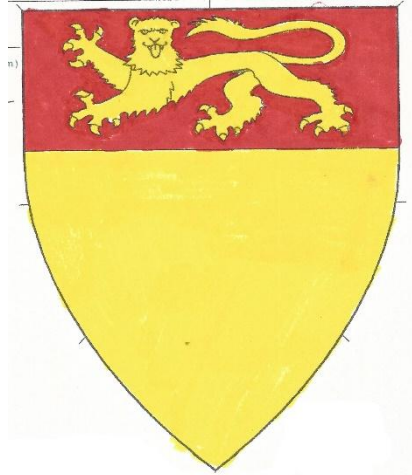
*Purpure, a martlet and on chief argent, three pairs of needles in saltire vert.*

*Or, on a chief gules, a lion passant guardant Or.*



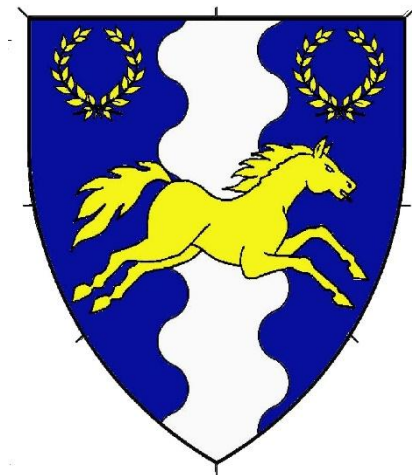

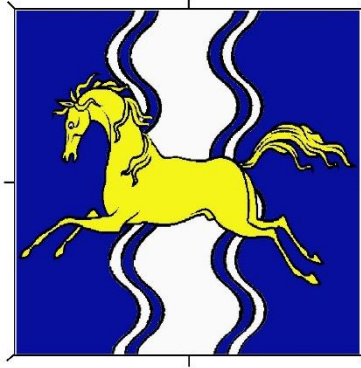
*Azure, a pale wavy argent between in chief two laurel wreaths and overall a horse courant contourny Or.*

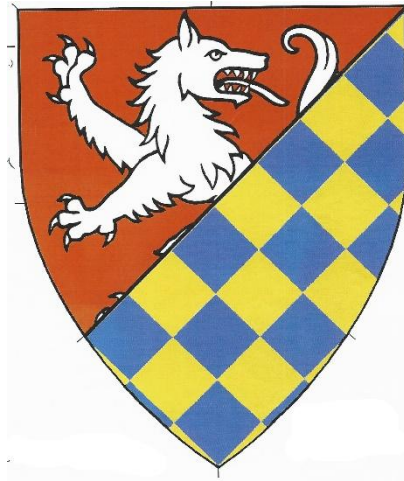

### **Grimkell of Bright Hills - New Device**

*Per bend sinister gules and lozengy Or and azure, issuant from the line of division a wolf rampant regardant argent.*



This device must be returned again for conflict with Johnathan Crusadene Whitewolf's badge "*Quarterly sable and gules, a demi-wolf rampant erased argent.*" As per SENA A5G7a, changes to the position of the head or tail do not count for difference. The only change made to the device is the position of the head, there for the device is still in conflict. Also please advise the submitter that a demi-wolf does not include the tail and hind legs.

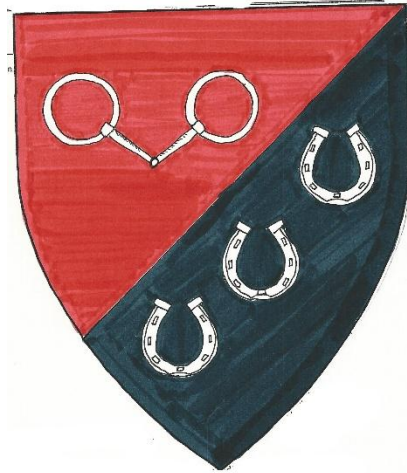
The device is a resubmission of the March 2015 Atlantian return of "*Per bend sinister gules and lozengy Or and azure, a demi wolf rampant issuant from a line of division argent.*"

Unfortunately, this device was returned for conflict with Johnathan Crusadene Whitewolf's badge "*Quarterly sable and gules, a demi-wolf rampant erased argent.*" There is distinct difference for changes to this field but there is no difference between the two wolves. Any proposed device must two distinct changes from any registered armory in order to be registered. Please advise the submitter that a demi-wolf does not include the hind legs.

### **Mór ingen uí Dochartaich - New Device**

*Per bend sinister gules and sable, a broken snaffle-bit inverted and three horseshoes inverted argent.*



This device is being administratively returned because payment for the submission has not been received by Golden Dolphin.

This device is pending until the July decision meeting to give the submitter time to submit payment for this submission. If payment is not received by the publication of the July external letter, it will be returned for lack of payment.

#### **Robert Carswell - New Device**

*Per bend sinister gules and Or, on a bend sinister azure between two trees blasted and eradicated, three triskelions sable*



This device must be returned for redraw because all elements of the design must have good contrast with one another. Without documentation for an individually attested patterns, we cannot have a black tree on a red background or black triskelions on a blue field as this is color on color.
